Room Rates - \$155 per room. Room rates are subject to 15.25% state and local taxes, plus a daily \$2 occupancy fee and a \$15 resort fee. The \$15 Resort Fee covers in-room amenities which include wired and wireless high-speed internet access in guest rooms and atriums, fitness center access, designated complimentary in-room beverages, scheduled shuttle service to Opryland Mills and area restaurants, daily newspaper, and local and toll free 800 telephone calls (20 minutes per call). Each room has two beds and costs may be shared by two occupants. Note that reservations received after August 16, 2010 will be accepted on a space available basis. Parking - \$16 per day self parking, plus tax per day for registered guest and includes in and out privileges

Transportation to/from Airport – Round Trip - \$38 (\$28 for Seniors 65 and older). One way - \$28 (\$18 for Seniors 65 and older). Auto Transportation – Interstate 40 West from Knoxville - Go west on Interstate 40. Proceed to Exit 215 and take Briley Parkway - 155 North. Go to and exit the parkway at Exit 12. Turn left off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland. **Interstate 40 East from Memphis** - Go east through Nashville on Interstate 40. Proceed to Exit 215 and take Briley Parkway - 155 North. Go to and exit the parkway at Exit 12. Turn left off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland. **Interstate 65 South from Louisville/Bowling Green** - Go south on Interstate 65. Proceed to Exit 90B to Briley Parkway – 155. Go east on Briley Parkway and exit at Exit 12. Turn right off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland. **Interstate 65 North from Birmingham** - Go north on Interstate 65. Proceed to Exit 90B to Briley Parkway – 155. Go south on Briley Parkway and exit at Exit 12. Turn right off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland. **Interstate 24 West from Chattanooga** - Go west on Interstate 24. Proceed to Exit 54 to Briley Parkway – 155. Go north on Briley Parkway and exit at Exit 12. Turn left off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland. **Interstate 24 East from St. Louis** - Go east on Interstate 24. Proceed to Exit 43 to Briley Parkway – 155. Go east on Briley Parkway and exit at Exit 12. Turn right off the exit ramp onto McGavock Pike. Turn left at the first intersection into the Gaylord Opryland.
